### Minutes

1. **Notice of convening the meeting**

REPORTED: The Registrar confirmed that due notice had been given.

2. **Amendments to the Articles of Association**

REPORTED: The Registrar provided a brief background to the proposed amendments.

In response to questions from Members and Fellows, the Registrar confirmed that membership is open to those involved in teaching and training veterinary and dental students and practitioners. This is explained in the revised Standing Orders, which will accompany the proposed amendment to Article 6.

AGREED: Annual General Meeting approved the following amendments:

(a) That Article 6 be amended to read:

**Membership shall be open to all those involved in the teaching and training of medical students and doctors.**

(b) That Article 36 be amended to read:

**Only members of the Association, who are in good standing, shall be eligible to hold office as a member of the Council save that the Council may appoint at any one time no more than two non-members of the Academy to serve on the Council in order to provide expertise not otherwise available to the Council as long as the prescribed maximum be not then exceeded. Such appointments shall be voting members of Council and shall retain office until the next Annual General Meeting. The officers of the Association shall be the President, the Chairman of the Executive Committee, the Honorary Secretary (who shall be the Company Secretary), and the Honorary Treasurer all of whom shall be members of Council.**
